# Annual General Assembly 2017 Resolutions

## **RESOLUTION 2017-003**

### **TTC TRUST – YANYEIDI**

#### **APPOINTMENT - Passed: July 11, 2017**

WHEREAS the Teslin Tlingit Council Trust (the “TTC Trust”) was established on March 15, 1999; All Trustees are legally obligated to act in the best interest of the TTC Trust and trust beneficiaries; act in strict accordance with the TTC Trust; carry out their duties with honesty and in good faith; be familiar with the terms of the TTC Trust; and avoid conflicts of interest.

THEREFORE BE IT RESOLVED THAT the General Council, as the Protector under the TTC Trust, confirms the appointment of Sarah Johnston Smith to the TTC Trust effective on the date that Sarah Johnston Smith consents to the appointment in writing.

## **RESOLUTION 2017-004**

### **AMENDMENT TO POST-SECONDARY EDUCATION ASSISTANCE POLICY (JANUARY 2017) - Passed: July 11, 2017**

WHEREAS Teslin Tlingit Council (“TTC”) government policies are important regulatory tools to inform funding decisions or priorities, such as providing post-secondary education assistance to Teslin Tlingit students; TETC and Management Board brought forward joint recommendations to the Executive Council on June 19, 2017 to amend the PSEAP in response to Resolution #2014-013) specifically to place a cap on the number of years a citizen can receive sponsorship and require all new students, if required to provide a career assessment, to complete the assessment in their first semester and provide the results to the CSDO; and

WHEREAS the Executive Council have reviewed the TETC and Management Board recommendations and recommend to the General Council to approve the following amendments to the PSEAP:

1. Section 3.0. Monitoring Process. Add the title “Timeframe for Graduation”.

2. Section 3.1.3. Incorporate the language “ For a four year degree program students will have a maximum of 48 months of

funding and an additional 16 months to complete a masters program, for a total of 64 months of funding based on eight month calendars.

3. Section 3.1.4. If a student changes their program or applies to go back to school after a break the limits outlined in section 3.1.3 apply. Once a student has received the maximum level of funding they will be ineligible for further funding.

4. Section 3.5. The TETC will request that all new students and other students provide a career assessment and that such assessment be completed in the first semester of their course and that a copy of the results be forwarded to the CSDO (the “amendments”).

THEREFORE BE IT RESOLVED THAT the General Council approves the amendments as presented in this resolution and such amendments are to come into effect on the date of this resolution.

## **RESOLUTION 2017- 005**

### **TESLIN TLINGIT COUNCIL (“TTC”) SUPPLEMENTARY BUDGET - 2017-2018 FISCAL YEAR - Passed: July 12, 2017**

WHEREAS the Executive Council presented and tabled the TTC departmental work plans (2017-2018) and a Core Operating Budget estimate for 2017-2018 (the “Core Budget”) in the amount of \$ 14,236,416.00 to the General Council on February 23, 2017 (Resolution # 2017 - 011). The Executive Council advised at the time of the presentation of the Core Budget that the Own Source Revenues (“OSR”) monies in the amount of \$271,600.00 may not be subject to an offset under the TTC Financial Transfer Agreement (“FTA”) for 2017-2018 (the “offset monies”). The Federal Minister for Indigenous and Northern Affairs Canada, Carolyn Bennett, announced at the Annual General Assembly for the Council of Yukon First Nations (in Carcross on June 28, 2017) that the Government of Canada confirms that there will be a three year moratorium on the offset requirements under the Yukon FTAs to

be retroactive as of April 1, 2017 to be in effect until March 31, 2020;

THEREFORE BE IT RESOLVED THAT the General Council approves the offset monies to be applied to the Core Budget for 2017-2018 and approves the supplementary budget in the amount of \$271,600.00

## **RESOLUTION 2017-006**

### **PAYMENT ON TESLIN TLINGIT COUNCIL TRUST - GRID PROMISSORY NOTE – CAPITAL EXPENDITURE**

#### **ROAD ACCESS IMPROVEMENT – SAWMILL SUBDIVISION - Passed: July 12, 2017**

WHEREAS the Teslin Tlingit Council Trust (the “Trust”) has issued to the Teslin Tlingit Council a grid demand promissory note dated November 29, 2006 in the amount of \$30,000,000.00 (thirty million dollars) (the “promissory note”) under which the Trust owes Teslin Tlingit Council \$18, 956,253.00 as of March 31, 2017.

WHEREAS the Executive Council is requesting that the General Council approve a demand notice to the Trust to issue payment on the promissory note of up to \$250,000.00 (two hundred and fifty thousand dollars) to be issued on or before September 15, 2017;

THEREFORE BE IT RESOLVED THAT the General Council authorizes the following

1. Executive Council to issue a demand notice to the Trust in the amount of \$250,000.00 dollars and that such monies be applied against the promissory note;

2. Executive Council request that the payment be issued on or before September 15, 2017; and

3. the monies are to be applied to the road access improvements to the sawmill subdivision.

## **RESOLUTION 2017-007**

### **CITIZENSHIP COMMITTEE**

#### **APPOINTMENT: DAKLAWEIDI -**

**Passed: July 12, 2017**

WHEREAS the General Council developed and approved the Teslin Tlingit Council Citizenship Code attached as Schedule "A" to the Teslin Tlingit Council Constitution on November 13, 2012 (Resolution 2012-006) (the "Code");

WHEREAS Billy Smarch has indicated his willingness and consents to serve on the Citizenship Committee for a term of one year;

THEREFORE BE IT RESOLVED THAT the General Council confirms the appointment of Billy Smarch to serve on the Citizenship Committee in accordance with the Code for a period of one year.

## **RESOLUTION 2017-009**

### **ENACTMENT OF LINGIT YOO X'ATANGI KA HAA SHAGÓON - passed July 12th, 2017**

WHEREAS the legislative committee has provided reports to the General Council in November 2016 and subsequently in February 2017 following the tabling of a draft law with the Executive Council in June 2017;

WHEREAS the legislative committee tabled a final report with the Executive Council that provided

a) an overview of the citizens and Elders Council's comments raised throughout the public consultations;

b) a copy of the final proposed Lingit Yoo X 'atangi k a Haa Shagóon for recommendation to the General Council to enact, if appropriate; and

c) the recommendation that the proposed law be suspended, with exception of section 10 to through 12 to allow for the Lingit Yoo X 'atangi k a Haa Shagóon oversight committee to operate immediately to develop and present a Lingit Yoo X 'atangi

k a Haa Shagóon mandate to the General Council in November 2017;

WHEREAS the Executive Council is satisfied that the legislative requirements to enact the proposed Lingit Yoo X 'atangi k a Haa Shagóon in accordance with section 48 of the Administration & Interpretation Act (1998) have been concluded and recommends to the General Council to enact Lingit Yoo X 'atangi k a Haa Shagóon as presented; and the General Council has reviewed the proposed Lingit Yoo X 'atangi k a Haa Shagóon herein attached to this resolution.

THEREFORE BE IT RESOLVED THAT the General Council enacts Lingit Yoo X 'atangi k a Haa Shagóon in accordance with section 48(6)(a) of the Administration & Interpretation Act (1998); THEREFORE BE IT FURTHER RESOLVED THAT sections 10 to and including 12 will come into force and effect on the date this resolution is executed, while all other provisions will be suspended until a date has been identified by the General Council at the November 2017 General Council meeting.

---

## **RESOLUTION 2017-010**

### **TRANSBOUNDARY NEGOTIATION MANDATE - passed July 12, 2017**

WHEREAS due to the increasing encroachment on our traditional territory located within British Columbia and the establishment of progressive legal principles by courts in Canada over the past 15 years, the General Council directed the Executive Council to establish a TTC negotiation team to re-engage with the Province and Canada for the negotiation of a treaty in accordance with a transboundary negotiation mandate (Resolution # 2016-007: November 23, 2016); the TTC negotiation team developed a draft transboundary negotiation mandate, in consultation with TTC elders and citizens and the relevant TTC departments, to provide guidance and direction with respect to the negotiation of a treaty that would be infused with key principles and objectives of the TTC Final and Self-Government Agreements and incorporate new treaty concepts and approaches developed over the past 20 years in British Columbia; and

WHEREAS the TTC negotiation team presented the draft transboundary negotiation mandate (herein attached to this resolution) to the General Council for its review and, if appropriate, approval.

THEREFORE BE IT FURTHER RESOLVED that the Executive Council:

1. approves the transboundary negotiation mandate dated July 7, 2017 (the "Mandate") herein attached to this resolution; and

2. directs the TTC negotiation team to:

a. engage with the Province and Canada for the negotiation of a treaty in accordance with the Mandate; and

b. provide periodic reports and updates to the General Council about the progress of the negotiations.

---

## **RESOLUTION # 2017- 011**

### **FINANCIAL TRANSFER AGREEMENT (FTA) - EXTENSION AND RENEWAL NEGOTIATIONS, LOBBYING AND LEGAL ADVICE - passed July 12, 2017**

WHEREAS FTA renewal negotiations have continued with Canada with the most recent FTA renewal negotiations being held on July 6th, 2017 in Whitehorse, and these negotiations are on-going, and will be held in Teslin, on August 22nd to 25th, 2017; The General Council mandated the Executive Council to seek legal advice to determine what grounds if any Teslin Tlingit Council may take legal action against Canada should a renewal not be achieved by March 2018.

THEREFORE BE IT RESOLVED that the General Council delegates to the Executive Council the authority to initiate the appropriate legal action if Executive Council deems it appropriate and expedient, and that this delegated authorization shall continue and be reviewed at the November 2017 General Council meeting.

---

## **RESOLUTION # 2017-012**

### **CHINOOK FISHERY - passed July 13, 2017**

WHEREAS the General Council passed a resolution at the Annual General Council Assembly (July 2016) to advance the long term conservation measures to support the sustainability of the Chinook and to ensure

there is salmon for future generations of Teslin Tlingit to harvest (Resolution # 2016-015: July 14, 2016); the General Council continues to support the Teslin Tlingit Council restoration and enhancement projects and the terms and conditions as outlined in Resolution # 2016-015;

WHEREAS in accordance with Haa Kusteeyi and the principles of conservation, self-regulation and protecting the interests of our children's futures that each clan identify an allowable Chinook harvest to be confirmed with the Department of Teslin Tlingit Lands and Resources through the clan's Executive Council member.

WHEREAS it is important that the Teslin Tlingit Council establish a salmon management plan that includes a political strategy to address the management of the Pacific salmon on the Yukon River and to ensure that the basic needs of Teslin Tlingit are more accurately reflected and understood by the Department of Fisheries and Oceans and other regulatory regimes.

THEREFORE BE IT RESOLVED THAT the General Council authorizes the following:

1. The terms and conditions as outlined in Resolution 2016-015 (herein attached to this resolution) remain in effect;
2. The Teslin Tlingit salmon ceremony continue as annual ceremony to be held on a date confirmed by the Elders Council and coordinated through the Department of Teslin Tlingit Council Lands and Resources; and
3. Teslin Tlingit citizens are approved to harvest Chinook for the 2017 harvest period on the following conditions:

(a) the Department of Teslin Tlingit Council Lands and Resources has issued a public notice (in the main administrative building) that the escapement has exceeded 55000 and citizens are allowed to exercise the harvest up to registered allowable numbers;

(b) each clan to establish a fish camp at a location of their choice and registered with the Department of Teslin Tlingit Lands and Resources; and

(c) each clan report their Chinook harvest to the Department of Teslin Tlingit Lands and Resources in accordance with the department's requirements.

THEREFORE BE IT FURTHER RESOLVED THAT General Council members are responsible to ensure that citizens of their

respective clans honor the spirit, objectives and requirements set out in this resolution.

THEREFORE BE IT FURTHER RESOLVED THAT the Executive Council in consultation with the Department of Teslin Tlingit Lands and Resources develop a Teslin Tlingit Salmon Management Plan and that such plan include a political strategy specific to the management of the Pacific salmon on the Yukon River and that the plan be presented to the General Council at the July 2018 Annual General Council Assembly.

---

#### **RESOLUTION 2017-013**

##### **YOUTH COUNCIL: CONSTITUTIONAL AMENDMENTS – passed July 13, 2017**

WHEREAS the Youth Council has tabled a document titled "Youth Council - proposed amendments to the constitution of the Teslin Tlingit Council" dated June 19, 2017 ("YC constitutional document") with the Annual General Council Assembly; the Youth Council recommends that the General Council approve the proposed technical and substantive amendments to the constitution at the July 2017 Annual General Council Assembly in accordance with section 50.3 of the constitution; and

WHEREAS section 50.3 of the constitution provides

50.3 Notwithstanding the preceding sections, this Constitution may be amended at any meeting of the General Council provided that there is unanimous consent by all members recorded as being in attendance to both the introduction of the amendment and the amendment itself.

THEREFORE BE IT RESOLVED that the General Council accepts the Youth Council's report and authorizes the technical and substantive amendments to the constitution as outlined in the YC constitutional document, in accordance with section 50.3 of the constitution.

---

#### **RESOLUTION 2017-014**

##### **ELDERS COUNCIL: CONSTITUTIONAL AMENDMENTS – passed July 13, 2017**

WHEREAS the Elders Council met on June 15, 2017 and recommends that the General Council amend the Constitution as follows:

1. Section 1.3 - to replace the term "language" with "speeches";

2. Section 5.5 - to correct the Lingit spelling of the clans and to remove the references to specific clan leaders; and

3. Section 23.4 - to remove the duplicate term of "Executive" (the "proposed amendments");

WHEREAS the Elders Council recommends that the General Council authorize the proposed amendments in accordance with section 50.3 of the Constitution; and

THEREFORE BE IT RESOLVED that the General Council authorizes the original text of the Constitution be replaced with the recommended amendments in accordance with section 50.3 of the Constitution.

---

#### **RESOLUTION 2017-015**

##### **EXECUTIVE COUNCIL: CONSTITUTIONAL AMENDMENTS (JUSTICE COUNCIL) – passed July 13, 2017**

WHEREAS the Executive Council has tabled a document with the General Council titled "Executive Council: proposed constitutional amendments (Justice Council)" dated June 19, 2017 (the "proposed amendments"), herein attached to this resolution, that outlines the amendments to section 8.3, 16.1, 16.3 and 16.5 of the Constitution; and the Executive Council recommends that the General Council authorize the proposed amendments in accordance with section 50.3 of the Constitution; and

THEREFORE BE IT RESOLVED that the General Council authorizes the original text of the Constitution be replaced with the proposed amendments in accordance with section 50.3 of the Constitution.

---

#### **RESOLUTION 2017-0016**

##### **TESLIN TLINGIT COUNCIL: DEPARTMENT – CREDIT CARDS – passed July 13, 2017**

WHEREAS the Executive Council requires the General Council's approval to apply for the corporate credit cards in accordance with section 12.1(c) of the constitution of the Teslin Tlingit Council.

THEREFORE BE IT RESOLVED THAT the General Council authorizes the Executive Council to approve of the number of TTC corporate credit cards required for the TTC departments and to apply for the TTC corporate credit cards each with a borrowing limit of \$10,000.00 (ten thousand dollars) per credit card.

# Community Capital Projects

## ***Biomass***

The Teslin Biomass Project is well underway. Biomass systems are very cost efficient, we will save over 100,000 litres of fuel each year, so approximately saving \$2 million dollars.

There are 3 phases the project. Teslin is currently at phase 1.

- Phase 1: Biomass District heating system consists of 10 burners installed to heat 10 buildings as a pilot project to test the viability of the system.
- Phase 2: most of the community infrastructure buildings in Teslin are heated with biomass.
- Phase 3: expansion to full commercialization (available to Teslin residents), supplying most of the community with heat and/or chips.

TTC started the construction of the Biomass producing buildings. There has been land development at the Charlie Jules Subdivision (Sawmill Road), clearing of land for connector road, access roads and culvert installation. All the logs that have been harvested from the subdivision are being hauled to the Land Treatment Facility, (YRT yard) for storage, once dry, they will be chipped for the heating system.

TTC will produce its own chips from local wood sources. Starting this fall, TTC will be purchasing wood from local woodcutters.

Throughout the project, many local residents and contractors have been employed. From clearing of the land, hauling supplies, pouring concrete and construction of the biomass buildings.

Eventually, by the end of phase 1, TTC will employ 1.5 -2 full time people, for maintenance and delivery, plus work for tree harvesters.

We are proud to say what a wonderful job the crew had accomplished through-out the past 2 summer seasons. Majority of the lumber used at the site was made at TTC's sawmill. Our Heritage Centre has many new features, including:

- Amphitheatre & rock fire place BBQ area
- Walkways and trails
- New viewing decks and seating areas
- New stairs to lead you down to beach area
- Newly built Elder friendly picnic tables
- Conversation rocks & fire pit
- Outdoor class room for moose hide tanning
- Hand-place rock banks
- New concrete patio deck and wheel chair ramp
- Dry river beds and rain garden
- New portable floating Dock
- Electrified trappers cabin and Boat house

The vision for the Heritage Centre has become a reality. The Centre will definitely reflect the needs of Teslin, our traditions, along with increasing cultural awareness for our people.



## Lands & Resources

### Wire Removal

Our Department partnered with the TRRC and Cosco Outfitting to remove over 3 kilometers of four-strand high tensile wire from an old corral south of Teslin. The wire was a concern for wildlife safety, particularly for moose, which can get fatally tangled. We would also like to thank our summer students, Susanna and Noah, as well as the University of Calgary volunteers, who all provided assistance in the field to make this project a success.

### Grizzly Bear Survey Results

We would like to announce the winner of the prize draw for survey participation. Congratulations to Kristyne Geddes – you've won a gift certificate to the Nisutlin Trading Post! Thanks again to everyone who participated. This information truly helps us serve TTC Citizens better.

### Invasive Plant Survey

Noah and Susanna have been running our third consecutive Teslin Invasive Plants survey. This work will help us understand our local environment better, as well as track any changes to plant communities over the years. This is important for many reasons, including local berry and plant medicine harvesting, as invasive species could overtake important local species Citizens rely on.

### Salmon Season

#### *Run size and harvest information*

Despite the large numbers being reported at the mouth of the river, Canada saw another year of below average Chinook salmon returns. This is likely due to a number of

factors, including harvest and a lower percentage of Canadian salmon in the total run. The final Canadian run size amounted to ~73,000, the lower end of the pre-season estimates, and marks a nearly identical run size to last year's 72,329. Yukon First Nations had limited fisheries, however the recreational, commercial, and domestic fisheries remained closed.

As per the 2017 salmon fishery resolution passed by GC and the July AGA, the Lands Department had a number of TTC Citizens register their intent to harvest a small number of salmon and obtain harvest reporting forms. While we have received some of these harvest report forms back already, we will be following up with those outstanding on our list this fall to ensure all harvest is reported. If you harvested salmon, and did not get a chance to register, please call or stop by the office to report your harvest. This information is critical to the ongoing management and protection of the Yukon River Chinook salmon.

#### *Deadman Creek Restoration Project*

The Deadman Creek restoration project continued this summer, marking the start of the first full-scale year of the restoration, making use of the methods tested in the 2016 pilot year of the project. This work is funded by the Yukon River Panel Restoration and Enhancement Fund and TTC. The project was assisted by a crew of 5 youth from Y2C2, and the department's two enthusiastic summer students, Susanna and Noah.

Egg planting sites (artificial redds) were prepared in Morley River and Deadman Creek over the course of a week, and egg collection and planting activities took place the following week, completed on August 18th. A small number of salmon from Morley River contributed broodstock (eggs and milt) for the project, and were released back to the river.

A portion of the eggs were planted into Morley River to provide a comparison to Deadman Creek monitoring, and the rest were transferred to Deadman Creek where they were fertilized and planted in prepared sites in the creek. We will be continuously monitoring the survival of the eggs, and working to improve our egg planting methods over the course of the restoration. Thank you to everyone who showed interest in the project, and we look forward to sharing more information as we progress!

This project also collected eggs for the Stream to Sea Program at Teslin School, placing 100 fertilized eggs in the aquarium for students to observe as they develop!



## Forest Planning and Biomass

The Lands Department has started discussions with the Yukon Forest Management Branch to develop a timber harvest plan for the area, along with the Teslin RRC. We will soon start discussing a harvesting plan in BC with provincial government staff as well. The overall goals of these first plans will be to detail where the wood will come from to satisfy needs of personal fuelwood users, the sawmill and the biomass project for the next 10 to 20 years, and to begin harvesting as a technique to reduce the risk of a catastrophic wildfire.

You may remember that Lands distributed a personal fuelwood questionnaire earlier this year and we have been trying to interview commercial fuelwood cutters. Many thanks to all those folks who participated in those information gathering sessions. Your information and views will be going to good use in these planning processes. Please watch for notices for public meetings to discuss the draft harvesting plans in the near future. Your input would be greatly appreciated.

## Sawmill Lot Distribution

After our very popular 11-lot lottery in the Sawmill Subdivision (all of which have now been allocated or leased to TTC Citizens), we have been able to make four more lots in the Sawmill Subdivision available for lottery, with applications being received until August 23rd at 5PM and the draw being held on August 30th.

Congratulations to all the successful applicants so far! It's great to see so many folks preparing to build their dream homes here in Teslin.



## *Hunter Safety Tips*

1. Always carry a waterproof fire-starting kit in a pocket. If you get wet, being able to start a fire is crucial to staving off hypothermia.
2. Have your boat, motor, and trailer serviced before the season starts. Make sure everything mechanical is in good running order and that batteries are at full charge.
3. Always wear a certified personal flotation device when running or paddling a boat.
4. Never go hunting without telling somebody where you're going and when you expect to return.
5. Stock your boat or ATV box with safety gear: survival rations, rope, flare gun, space blanket, hand axe, whistle, etc
6. Attach a small compass to your parka via pin or string. This way, it'll always be there when you need it.
7. Never attempt to run an overloaded boat. If hunting on a large river or lake, use a boat that's big enough to handle rough water.
8. Treat every gun as if it's loaded, even when you're sure it's not.
9. Before each hunt, open your gun's action and check the muzzle for obstructions.
10. Carry a cell phone in a waterproof plastic bag when hunting. Cell phone service is available in most places around the country. If an emergency arises, you can call for help.
